Terms and Conditions

The following terms and conditions relate to entry in the Everything Chrysler Day ["Chrysler Day 2017"] held by the Charger Club of WA Inc. ["the Club"] on 2nd April 2017 at the Perth Motorplex.

1. In signing the entry form, I do hereby for myself, waive and release the Club, its officers and all individual members thereof, and all other persons regardless of their capacity in any way connected with the Chrysler Day 2017 from any and all right, claim or liability of any kind or nature that I might have. I do hereby acknowledge that this waiver and release will extend to any accidents, damages or claims arising out of my entry caused by my own acts or caused by anyone outside my control. I further acknowledge and agree that I will be personally liable and accept full responsibility for any and all damage I, or any person within my control, may cause to the grounds upon which the Chrysler Day 2017 is held or any equipment, vehicles, buildings, facilities or items used in connection with the Chrysler Day 2017.
2. All vehicles must be in place by 9.00 am on Sunday 2nd April 2017 and shall not be **started, leave or moved** from its designated position before 4.00 pm, except for Club sanctioned driving events. If your vehicle does need to be moved or have to leave early [only acceptable in the case of an emergency] it must first be authorised by an official of the Club. A speed limit of 10 kph applies and all vehicles must comply.
3. Vehicles moving for Club sanctioned driving events must observe the 10 kph speed limit while in the staging area and absolutely no burnouts will be tolerated in this area.
4. Driving events will be conducted according to the Australian Auto-Sport Alliance (AASA) Rules and Regulations.
5. No drinking glasses, glass bottles or other glass containers are permitted on the grounds.
6. No alcohol may be brought in or consumed in the vehicle display and competition areas.
7. No excessively loud noises or sound systems are permitted without prior approval of the Club.
8. Vehicles entered for judging must allow the judges access to the engine bay, boot and interior for judging. If your vehicle is unattended and locked when the judges come to view it and they cannot access the required areas, the vehicle **will not be judged**. It is recommended that vehicles to be judged remain unlocked at all times.
9. Every effort is maintained to ensure that the judging system is fair, unbiased and transparent. The judge's decision is final and no correspondence will be entered into.
10. **Last entries for judged vehicles will be Friday 17th March 2017.**
