Terms and Conditions

The following terms and conditions relate to entry in the Chrysler Expo ["Expo 2013"] held by the Charger Club of WA Inc. ["the Club"] on 10th February 2013 at Lathlain Park.

1. In signing the entry form, I do hereby for myself, waive and release the Club, its officers and all individual members thereof, and all other persons regardless of their capacity in any way connected with Expo 2013 from any and all right, claim or liability of any kind or nature that I might have. I do hereby acknowledge that this waiver and release will extend to any accidents, damages or claims arising out of my entry caused by my own acts or caused by anyone outside my control. I further acknowledge and agree that I will be personally liable and accept full responsibility for any and all damage I, or any person within my control, may cause to the grounds upon which Expo 2013 is held or any equipment, vehicles, buildings, facilities or items used in connection with Expo 2013.
2. All vehicles must be in place by 9.00 am on Sunday 10th February 2013 and shall not be **started, leave or moved** from its designated position before 4.00 pm. If your vehicle does need to be moved or leave early [only acceptable in the case of an emergency] you must approach a representative of the Club to organise safe passage. A speed limit of 10 kph applies on the oval and all vehicles must comply.
3. No drinking glasses, glass bottles or other glass containers are permitted on the oval.
4. No excessively loud noises or sound systems are permitted without prior approval of the Club.
5. Vehicles entered for judging must allow the judges access to the engine bay, boot and interior for judging. If your vehicle is unattended and locked when the judges come to view it and they cannot access the required areas, the vehicle **will not be judged**. It is recommended that vehicles to be judged remain unlocked at all times.
6. Every effort is maintained to ensure that the judging system is fair, unbiased and transparent. The judge's decision is final and no correspondence will be entered into.
7. Cost for participation in Expo 2013 is \$25 per vehicle for judging and \$15 per car for display only. **Last entries for judged vehicles will be 1st February 2013.**
